ASSOCIATE MEMBERSHIP REQUEST FORM

THE BRITISH NATIONAL REGISTER OF ADVANCED HYPNOTHERAPISTS is a nationwide register of advanced professional hypnotherapists and trainers committed to providing the most effective treatment, delivered at the highest professional standard, to their patients. It is the intention of the NRAH to enhance the public awareness of the benefits of hypnosis/hypnotherapy by portraying a professional image of hypnotherapists and hypnosis.

Membership is conditional on

- Applicant must be registered with the CNHC. Registration can be arranged if not already registered. (see NRAH website for CNHC application form)
- Applicants must hold a qualification in either hypnotherapy, NLP or psychotherapy. Associate membership is open to a graduate of any NRAH affiliated training school who has not completed two years in practice as a hypnotherapist. They must show a commitment to on going personal development. Associate members may work in unrelated professions. Associate members names will not appear on the register of advanced hypnotherapists.
- A certificate will be issued to show associate status. This does not entitle the associate member to use the designatory letters of the NRAH. An associate member may not be eligible for certain discounts offered to full members.
- If needed, a reference will be given to enable an associate member to obtain professional liability insurance or to satisfy any enquiry made by a potential client.
- Applicants must be able to show a commitment to their own ongoing professional development through such things as attending advanced/master class training courses, and to guarantee that they will continue with their ongoing professional development. A minimum of 30 training credits in any 12 month period are needed to maintain membership. (see website for details)
- Before working with clients, members must hold an up to date public indemnity/liability insurance for a minimum of two million pounds (£2.m)
- Applicants must supply the name and address of an existing NRAH member who is willing to sponsor the application or a letter of introduction from an NRAH affiliated training school/collage

All members must adhere to our Code of Ethics.
Membership fee: £40 plus a one off registration fee of £15.
